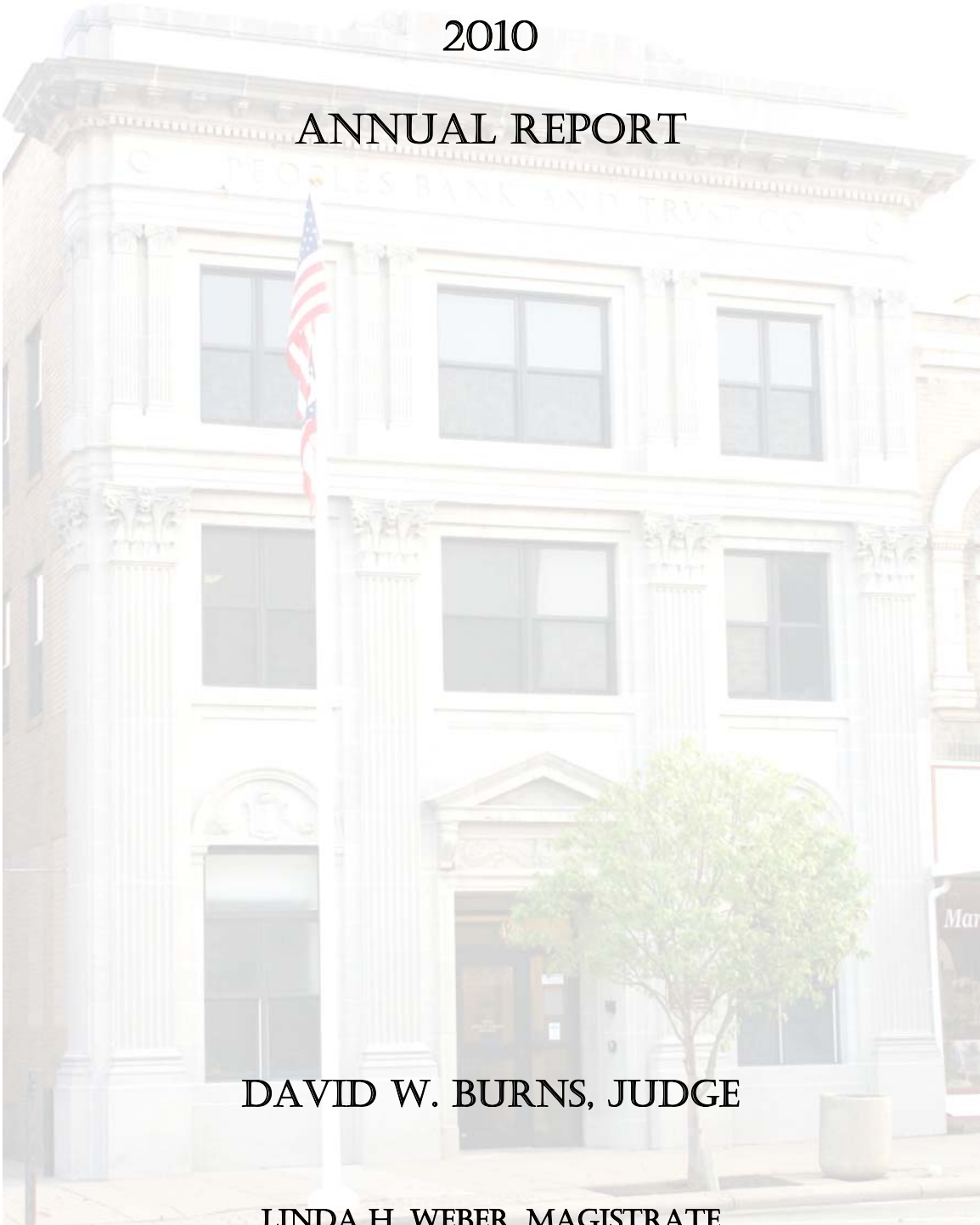

2010 - The Year In Review

The Coshocton County Court of Common Pleas, Probate & Juvenile Division saw many changes in 2010, and was no different than other businesses and governmental agencies that have been impacted by budgetary issues. While looking at technology for efficiency combined with a reduction in staffing, the Court was still able to implement some very important programs and changes for efficiency in operations. In April of 2010, Digital Imaging was added as a means of document storage. While this technology is expensive, Grant Funding and the use of the Court's Computer Fund allowed for this update without the need to access any general fund dollars. While we have not yet done full implementation, we have moved another step closer to being able to eliminate stacks of files and records that have plagued the judicial system for years. In addition, the court replaced an aging and unreliable camera system, and now has some 29 cameras that are monitored by staff and security within our building. This system was purchased with General Fund dollars left at the end of 2010 and with newly created Security Fund dollars. The goal for the future is that any security needs or updates will be fully supported with Security Fund Dollars, so again the operation will not need to budget this into the General Fund Budget.

The Community should be proud of interior improvements at the Court with small steps to show our pride. From front window displays to artwork from local Hopewell students to newly painted walls and waxed floors, the staff appreciates being able to provide a professional yet comfortable environment for the public.

While we have a great relationship with many community partners, we continuously strive to build upon and improve these relationships. Our local Child Support Enforcement Agency works very closely with the Court, and we have instituted monthly meetings to review processes and discuss areas that we can improve efficiency to serve the public more effectively. Updates in local Court Rules, access to forms, and sending correspondence with electronic media are examples of this collaborative effort. In addition, we continue to have dialogue with Southeastern Ohio Legal Services to have forms updated and plan to have many accessible online at the Court's Website in the near future.

Finally, the Court has expanded its list of contract providers and volunteer support, with a goal of having at least 30 volunteers for its newly created Mentoring Program, which was able to start with the generous support of the Schooler Family Foundation. I encourage anyone in the community that has interest in this or other programs to contact the Court and be involved in the process to become an active champion for change. We value community input and take all suggestions seriously.

General Court Information

Approximately 479 hearings were handled by the Judge and 365 by the Magistrate for a total of 844 in 2010. These do not reflect that actual number of cases heard, as many hearings such as traffic and drug court have multiple cases in court at the same time.

The Child Support Attorney processed approximately 188 pretrial cases for child support. Child Support Clerks processed 1,220 Title IV-D & Consent Judgment Entries. Approximately 138 Private Entries were processed by the Child Support Clerks.

Community Service: Youth are placed for work on an individual basis from delinquency cases. Most Diversion Youth complete 8 hours community service and other delinquent youth complete and average of 16-24 hours each.

Juvenile Traffic Cases: There were a total of 119 Traffic Cases in 2010 with 77 Court Appearances at 13 traffic Court Hearings. Of the total offenders, 17 were second offenders and 1 third time offender.

Traffic Safety Seminar: First time juvenile traffic offenders are ordered to attend this 1.5 hour program with a parent at the Coshocton County Career Center. The session focuses on safety issues for young drivers and responsible driving. Presenters include local accident survivor Clayton Stone, an Ohio State Highway Patrolman, and an EMT from Coshocton County EMS.

Juvenile Traffic Violation Bureau: A new Court Program in 2009, this program allows first time traffic offenders with certain minor violations to enter a written plea and waive the appearance in Court as long as fines, costs, and traffic seminar attendance is met.

Alternatives to Jail: A unique program in Ohio as a joint venture with the Child Support Enforcement Agency looks at alternatives to jail as an option for Adult Child Support Cases that are behind on support payments. The program has agreements with non-profit agencies and private businesses to allow community service work at their sites.

School Truancy Program: The School Truancy Program is a collaborative effort between the Juvenile Court, Coshocton Job & Family Services, and the Public School System in Coshocton County. The primary goal is to assist schools with compulsory education laws and to identify students with attendance issues. A series of notices are filed with the court and the family of the truant child in an effort to resolve attendance issues. Informal hearings are held in the schools to address attendance issues without having formal Court or Job & Family Services involvement. If these issues are not resolved, juveniles will have a School Truancy charge filed.

Juvenile Drug Court Program: Started in 2002, the Coshocton County Juvenile Drug Court Program continues to work with identified offenders that have significant substance abuse histories. Weekly court hearings as well as treatment, mental health counseling, education, and family support are major components to this intensive non-traditional program. The four phase program takes participants one year minimum to complete.

Muskingum County Juvenile Detention Center: Coshocton County Juvenile Court contracts with the Muskingum County Juvenile Detention Center for use of beds. The Detention Facility is located at 1860 East Pike, Zanesville, Ohio and is a 48 bed state of the art secure detention facility, which has 4 pods of 12 youth, one of which is designated for females. The facility employs two fulltime nurses and contracts with Zanesville City Schools for educational staff. The Detention Facility is approximately 45 miles from Coshocton.

Video Detention Hearings: The Juvenile Court purchased 3 laptop computers equipped with cameras in June, 2009. These computers allow the Court to conduct video detention hearings on those youth that were detained after-hours or on a weekend, thus saving on the burden of transportation by a sheriff's deputy both to and from the Juvenile Detention Facility in Zanesville, Ohio. Once a child is released from the detention facility, parents assume responsibility for transportation of their minor youth. Approximate cost savings per hearing held is in excess of **\$275.00** to the County.

Diversion Program: Coshocton County Juvenile Court received a "Challenge Grant" in 1998 which has enabled the court to hire an employee to develop a Juvenile Diversion Program. The Diversion Officer continues to be paid out of Grant Funds. Diversion was implemented in January 1999. The Diversion Program is designed to give less serious first time offenders an opportunity to amend their wrong doing. This program has an average time period of 90-120 days. If the juvenile completes required programming they will not have a blemish on their record. However, if the juvenile does not complete the Diversion Program they will have their original charges filed against them in Juvenile Court.

Intensive Probation Program: The court received funding from Coshocton Job & Family Services to continue a night monitoring program that has proven to be a valuable asset. Specialized populations of juvenile offenders including drug court youth, felony offenders, and youth with sexually acting-out behaviors were main focuses of the evening check program. Drug testing and accountability are key components to the success of the program.

Mentoring Program: Near the end of 2010 the Court received a generous grant award from the Schooler Family Foundation to establish a mentoring program. This program utilizes volunteers that have undergone criminal history checks and an interview process. The goal for this program is to match positive adult role models with identified at-risk and court involved youth. The focus age group is 11-16, but other factors are considered. Currently 7 youth are matched and 12 adults have been approved as mentors, with another 14 adult prospects identified. A Target Goal of the Court is to have 30 youth matched by the end of 2010.

Drug Testing: As part of the court's probationary terms, most youth involved with the court are given random drug and alcohol tests.

Nurturing Parent Program: In 2010, at least 49 families completed Family Parenting sessions with their minor children. A focus is on communication skills between teens and parents, effective interventions, and respect for the family members. Renewed understanding of current issues allows for better relationships as evidenced by pre-test and post-testing data.

Anger Replacement Therapy: In 2010 31 youth completed this program at Thompkins Adolescent Services. It focuses on anger identification, role playing, and ways to displace angry thoughts with interactive and proven methods. Homework is assigned weekly during this group process. Additional youth may have participated at Coshocton High School Careteam or the Opportunity School for this program.

SAY Program: 5 youth were involved in this treatment program in 2010. It is not a time limited program, and generally takes 1-2 years to complete. The focus is for appropriate sexual boundaries, relationship issues, and community and personal safety relating to sexual issues. Regular review sessions are held in court for updates and accountability.
